**CENTRALISED SECOND PHASE ALLOTMENT TO**  
**ENGINEERING/ PHARMACY COURSES AND FIRST PHASE**  
**ALLOTMENT TO ARCHITECTURE COURSE PUBLISHED**

The second phase allotment to Engineering/ Pharmacy Courses and first phase allotment to Architecture Courses-2024 are published on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

The details of allotment of candidate such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details** etc. will be available on the home page of the candidate as well as in the Allotment Memo.

**Allotment Memo and Data Sheet**

Candidate's who have an allotment should take a printout of Allotment Memo from the home page. The Allotment Memo available in this phase will not be available later. Hence, candidates shall have to keep copy of the Allotment Memo for future reference. Candidates who have an allotment can download the '**Data Sheet**' containing the basic details of the candidates by clicking the menu '**Data Sheet**' available in the home page. The printout of the Allotment Memo and Data Sheet along with the documents prescribed

(as applicable) in clause 11.7.1 of the Prospectus are to be produced before the college authorities at the time of admission.

### **Fee Payment**

Candidates who receive an allotment in Engineering/Pharmacy afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the Allotment Memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **21.08.2024 to 27.08.2024, 2.00 PM** and should join the course/college allotted before **3.00 PM on 27.08.2024**. Candidates who receive an allotment in Architecture course should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the Allotment Memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **21.08.2024 to 24.08.2024, 2.00 PM** and should join the college allotted before **3.00 PM on 24.08.2024**. The list of Post Offices having facility for fee payment is available in the website.

The candidates of Engineering/ Pharmacy Courses who get a change in allotment other than that of the first allotment should pay the balance fee, if applicable, within the time mentioned above. These candidates (including the candidates who got the allotment in the first phase also) should also join the course/college allotted as per the Allotment Memo before the time prescribed.

Candidates shall have to remit the fees applicable to the allotted colleges at the time of admission.

**Those candidates who do not remit the fee/balance fee (applicable) and who do not join the course/college (for Engineering and Pharmacy including the candidates who got the allotment in the first phase)**

**allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs.**

### **Joining Schedule**

All the candidates who have an allotment should join the course/college allotted as per the Allotment Memo from **21.08.2024 to 27.08.2024** for Engineering and Pharmacy courses and from **21.08.2024 to 24.08.2024** for Architecture course. The detailed schedule showing the date and time for joining the Engineering, pharmacy and Architecture courses has been published in the website of the Commissioner for Entrance Examinations. **Candidates who have got allotment shall have to visit the website of the Commissioner for Entrance Examinations in order to have information regarding the date and time of the joining.**

### **Third Phase Allotment**

Facility for **fresh option registration** will be provided for Engineering and Pharmacy courses for Third Phase allotment. Detailed notification regarding next phase allotment to Engineering, Pharmacy and Architecture courses will be published later.
