KEAM-2024 ADMISSION TO MBBS/BDS COURSES

REVISED STRAY VACANCY ALLOTMENT LIST PUBLISHED

As per the MCC Schedule dated 13.09.2024, the MCC had instructed State Counselling Authorities to commence the Stray Vacancy Phase allotment on 25.10.2024 and to complete on 29.10.2024. Accordingly, this office commenced the stray phase activities on 25.10.2024 and published the final allotment on **29.10.2024**. Later, vide notice no. U-11011/01/2024-MEC dated 30.10.2024, the MCC has directed to weed out the AIQ allotted candidates who have got allotment in the State quota allotment list in the Stray Vacancy Filling phase. Hence, the allotment list published vide notification dated 29.10.2024 is hereby revised by excluding those who have got allotment in AIQ Stray Vacancy Filling Round and the revised Stray Vacancy allotment list is published in the website of Commissioner for Entrance Examinations www.cee.kerala.gov.in. The candidates who have already taken admission vide notification dated 29.10.2024 may take TC and join the newly allotted colleges/course, if applicable, as per the revised list. Other candidates who have not yet taken any admission vide notification dated 29.10.2024 may directly join the colleges allotted at this stage.

The allotted candidates can take printout of the allotment memo from the candidate portal. The details of allotment of a candidate such as **Name**, **Roll Number**, **Allotted Course**, **Allotted College**, **Category of Allotment**, **Fee details etc.**, are available on the home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment should remit the fees as shown in the allotment memo to the allotted college and should join the course/College on or before **05.11.2024**, **4.00 PM**. Candidates allotted under SC/ST/OEC/ Fishermen category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated 23.05.2014, and those candidates from Sree Chitra Home, Juvenile Home, Nirbhaya Home need not pay the tuition fee. However, if they are allotted under Minority/NRI quota seats in Self- financing Medical/Dental colleges they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu 'Data Sheet' available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission.

Those candidates who have an allotment should join the course/college as per the allotment memo before **4.00 PM on 05.11.2024**. Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment and the registration fee of such candidates will not be refunded and will be penalized as per KEAM Prospectus clause 12.2.4. Those candidates, who quit seats after taking admission either through stray vacancy allotment or through previous allotments conducted by Commissioner for Entrance Examinations, will be penalized as per KEAM Prospectus clause 12.2.4.
