ADMISSION TO INTEGRATED FIVE YEAR LLB COURSES 2024
SECOND PHASE ALLOTMENT PUBLISHED

The Second Phase of Centralized Final Allotment for admission to Integrated Five Year LL.B Course in Government Law Colleges and Government Seats in Private Self-financing Law Colleges of the State for the year 2024-25 is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank in the rank list of Integrated Five Year LL.B course published by the Commissioner for Entrance Examinations and online options registered/confirmed by the candidates within the stipulated time. The online options registered by the candidates whose results are withheld have not been considered for allotment.

Candidates can access their homepage by entering their application number and password in the '**Integrated Five Year LLB 2024 - Candidate Portal**' provided in the website. By clicking the menu '**Allotment Result**', candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees etc., are available in the allotment memo. Candidate shall take a print out of the allotment memo. Candidates can log on to their Home Page and then click the Menu '**Data Sheet**' for downloading the Data Sheet.

Candidates who receive allotment should report for admission before the Principal of the allotted colleges on or before **30.10.2024, 3.00 PM**.

Candidates should report along with the allotment memo and original documents specified in Clause 19 of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. Candidates will be liable to pay at the revised rate as

and when the fee for the academic year 2024-25 in the Government Law colleges are revised. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) on **30.10.2024, 4.00 PM.**

Candidates belonging to SC/ST/OEC/Communities eligible for Educational concessions as is given to OEC/Candidate eligible for Fee concession as per G.O. (Ms)NO.25/2005/SCSTDD. Dated.20.06.2005/Children of Fisherman/Inmates of Sree Chitra Home/Nirbhaya Home/Juvenile Home are exempted from remitting tuition fees.

Candidates who do not join the college on the specified dates, will lose their present allotment and also the higher order options. Their existing options will not be considered for further allotments, if any. The details regarding further allotments will be notified later.

Note: 1. Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status.

2. Allotment/admission of candidates whose writ petitions are pending disposal in Hon'ble High Court of Kerala is provisional in this phase, and will be finalised on receipt of respective court orders.

3. Candidates who receive a change of allotment to their higher options in the second phase of allotment will automatically lose their current admission of the first phase. If the candidate has a change of college to their higher options in the second phase, they should obtain the T.C, relevant documents and amount remitted at the time of admission from their currently admitted college and join the newly allotted colleges within the specified date notified by the Commissioner for Entrance Examinations.

4. Vacancies that may exist in various Government and Self Financing Law Colleges after the second phase of Centralized Allotment shall be filled by vacant seat allotment to be conducted by the Commissioner for Entrance Examinations as per clause 18.19 of Integrated Five year L L B Prospectus 2024. The date for the same will be published later.
