ADMISSION TO INTEGRATED FIVE YEAR LLB COURSES-2024 VACANT SEAT ALLOTMENT - FINAL LIST PUBLISHED

The Online Final Vacant Seat Allotment to the Integrated Five Year LLB courses 2024 to fill up vacant seats in the Government Law Colleges and government seat in Private Self Financing Law colleges in the State having seat sharing agreement with the Government is published in the website www.cee.kerala.gov.in. The Vacant Seat Allotment has been prepared after addressing valid complaints received within stipulated time regarding Provisional Allotment List published on 12.11.2024. The Vacant Seat Allotment has been prepared on the basis of the conditions stipulated in the Integrated Five Year LLB Prospectus clause 18.

To view the Allotment Result, candidates should log on to the 'Integrated Five Year LLB 2024-Candidate Portal' by submitting their Application Number and Password. Then by clicking on the link 'Allotment Result, candidates can view their Allotment Result. It is necessary to take the printout of the Allotment Memo. The allotted candidates should report for joining at the allotted colleges from 14.11.2024 to 18.11.2024, 3.00 PM, along with all required documents specified in the Allotment Memo as per Prospectus clause 19.

General Rules of Vacant Seat Allotment:

- 1. If no seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, shall prevail, and if a seat is allotted to the candidate in the vacant seat allotment, the existing admission, if any, will stand cancelled and the candidate shall have to accept the new allotment.
- 2. The seats received through vacant seat allotment cannot be changed further at any instance.
 - 3. Candidates who are allotted a seat in the vacant seat allotment

(irrespective of the admission status) will not be eligible for any subsequent allotments.

- 4. Allotment shall be subject to the final order/affiliation/approval of the Govt./Bar Council of India/University concerned.
- 5. The Vacant Seat Allotment Registration Fee of those candidates who do not join the seat allotted through Vacant Seat Allotment will be treated as penalty and will not be refunded.

In case vacancies exist/new vacancies arise after Vacant Seat Allotment, these will also be filled in the subsequent phase through Spot Allotment/Stray Vacancy Filling Round, based on the options registered for the Vacant Seat Allotment. The Guidelines for Stray Vacancy Filling round will be notified later.
