**ADMISSION TO INTEGRATED FIVE YEAR LLB COURSES-2024**  
**STRAY VACANCY PROVISIONAL ALLOTMENT LIST**  
**PUBLISHED**

The First round Stray Vacancy Provisional Allotment List for admission to Integrated Five Year LLB Courses for the academic year 2024-25 in the Government and Private Self Financing Law colleges is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank list of Integrated Five Year LLB course published by Commissioner for Entrance Examinations and online options registered by candidates from **19.11.2024 to 21.11.2024, 3.00 PM**. The online options registered by candidates whose results are withheld have not been considered for allotment. The provisional list of allotment is available in the website of the Commissioner for Entrance Examinations **www.cee.kerala.gov.in**.

**General Conditions**

1. The seats received through stray vacant seat allotments cannot be changed at any instance.
2. Candidates who are allotted a seat in the vacant seat allotment and stray vacancy seat allotments (irrespective of the admission status) will not be eligible for any subsequent allotments.
3. Candidates who have an admission will not be considered for stray vacancy allotments and college level allotments even if they have registered options in this phase.
4. After the first round Stray vacancy seat allotment, if vacancies exist/arise, these vacancies shall be filled through Second Round Stray Vacancy Filling Allotment. For Stray Vacancy Filling rounds, options registered by candidates during the First Round Stray Vacancy Seat Allotment is considered.

5. The various lists of candidates for the college level stray vacancy filling after the stray vacancy seat allotments will be prepared based on the options registered for the first round stray vacancy allotment process. But the options registered in first round stray vacancy allotment by already admitted candidates will not be considered for college level stray vacancy filling rounds.
6. Those who have vacated the seat after 11.11.2024, 1.00 PM will not be eligible for stray vacancy round allotments even if they have registered options in this phase.
7. Allotment shall be subject to the final order/affiliation/approval of the Govt./Bar Council of India/University concerned.

Any discrepancy in the Allotment List may be informed to Commissioner for Entrance Examinations on or before **2.00 PM on 22.11.2024** through the Email ID : **ceekinfo.cee@kerala.gov.in**. Final allotment will be published after addressing the complaints (if any).

*Note: Candidates who have claimed SC/ST reservation and whose caste status is under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be provisional and subject to final verification of their caste status.*
